- a. May's financials look good as well as having a good April. Our mortgage is now under \$600,000.
- b. There have been some computer issues which can decrease productivity. Chris is working on possible solutions and options.
- c. Safeguard Iowa, who met with our security team, has been feeling a funding crunch. They are trying to find funding to stay afloat. We need a final report from him and will then get the security team together.

Financials Report – Brian Frantum

Brian reviewed the financial report as printed. We have a very strong cash liquidity.

Attendance report – Chris Thomson

We had 2 Sundays with under 800 in attendance, may be due to young families traveling.
